That Which Cannot be Denied (TWCBD)

About the Book

In his stirring, witty memoir, *That Which Cannot Be Denied*, first-time author Roger M. Hughes chronicles the mesmerizing exploits of his family. Spanning 130 years, four generations, and four continents, Hughes invites readers into the lives of his brave and adventurous great-grandfather: his cantankerous grandfather, his decorated war hero and spy father, and into his own life—finding his identity in the world and becoming a successful trial lawyer.

Roger describes in striking detail how each generation of his family became an integral part of the history of their time and place, each disregarding their legacy and finding their own way to pursue historical and cultural opportunities.

Growing up, the son of a Marine aviator and spy, Hughes attended 14 different schools between Kindergarten and High School Graduation. He overcame dyslexia, became a leading man in high school theatre productions, won prestigious awards, including the Utah state championship in debate, and successfully fought off angry protestors at his home in Egypt at the tender age of 18. When Roger was 19, he traveled the world on his own. He was the first in his family to receive a college degree—going on to become a successful trial lawyer.

This beautifully written and powerful book captures the exciting lives of four generations of the Hughes family and tells the touching story of how Roger found his true purpose in life.

Discussion Questions

- 1. How do you think Agnes felt when she sailed steerage class across the Atlantic with her new husband (for just a couple of days), knowing she would never see her family and friends again?
- 2. Do you think Henry considered leaving Kansas and returning to England when Agnes died?
- 3. How do you think Henry felt when his teenage son ran away, leaving him to tend to the family farm alone?
- 4. What do you think attracted Curly to the logging camps of California?
- 5. How must Myrtle have felt having to choose between her sister and her potential husband?
- 6. Consider this quote from the book; "Undoubtedly, my grandfather and grandmother were bound together by necessity, and their significant differences were of little consequence given what they faced." How did Myrtle and Curly make a life together when they were so different?
- 7. How do you think Harry developed an interest in mechanical things as an only child when his father worked long days every day tending to the gambling saloons, restaurants, and homemade grape juice business?
- 8. Can you imagine how Harry felt when local police regularly targeted him because of the animosity between his father and the police?
- 9. Why do you think Curly was furious about Harry enlisting in the Marines? Do you think he was motivated by concern for his son's safety or hatred of the military and the government it represented?
- 10. Considering the heavy toll it placed on Harry to live his life as a Top-Gun pilot in the Korean War while at the same time providing a home for himself and his family in Hawaii, how do you think he was able the reconcile these drastic differences in lifestyle?
- 11. What does the story of Fujisan as a stowaway on a commercial airliner reveal about Irene's sense of humor and her relationship with her boys?
- 12. How do you think Irene felt traveling as the only civilian woman on a navy ship in the middle of a monsoon with her grade school sons?

- 13. Consider this quote from the book "The streets, neat and clean, were tightly packed with little shops, sliding bamboo doors, and windows without glass. Pennants, bamboo birds, and whirling little fans danced with the slightest breeze; vegetables and fruit were on display, neatly stacked; kids ran up and down the dirt streets, trailing red, blue, and orange kites, as little bamboo pinwheels whirled frantically." Can you imagine how it felt to be a young child in such an exotic place?
- 14. Consider the quote from the book "Though Dad was a highly decorated Marine who had flown in two wars and the Formosa conflict under enemy fire and was less than a year away from vesting, the Corps unceremoniously handed him discharge papers." How do you think Harry felt about his commitment to the Marine Corps and the sacrifices he and his family had made for the war efforts after he was denied the military retirement given to other less qualified, less decorated marines?
- 15. Discuss Roger's nuclear family dynamic while living in Salt Lake City. Can you imagine how Roger felt: winning a state award in debate without the support or attendance of his family, learning how to ski, and then skiing every day after school without his brother or parents?
- 16. After spending his childhood living in exotic locations around the world, do you think it was unusual for Roger to be awestruck by the alluring, peculiar, and unfamiliar sights/sounds of Manhattan Beach?
- 17. Do you think Mrs. Reed and Roger's friends in the drama department were essential to him because his brother and parents did not contribute to Roger's learning or his need to feel loved?
- 18. Do you think Roger's first impressions of Cairo were colored and perhaps enhanced by the hint of international intrigue and surveillance for which Herb prepared him? Thinking about your own life, do you remember a time when you felt like you were being followed?
- 19. Can you imagine how it would feel to take up arms to defend your family home from an angry mob at the tender age of 18 years old? How do you think Roger felt when he discovered what was really in his parents' locked armoire?
- 20. Thinking back to Roger's desperate situation of hitchhiking alone in Yugoslavia in the middle of winter, do you remember a time when you were young and impetuous, and your recklessness got you into serious jeopardy? If so, explain how you felt.
- 21. What do you think Harry meant when he told Roger, "The desert can keep a secret?" What do you think Harry did during frequent junkets into the desert? Who did he take with him, and why?

- 22. Can you imagine how Roger, at only 19 years of age, felt coming home after two years of traveling the world to live with his aging, infirm grandmother and being responsible for preparing the home for her move into a care facility? How do you think he felt taking on this responsibility immediately after coming to live with her at such a young age? When you were a young adult, were you confronted with aging, illness, and death?
- 23. How did Roger's father prepare him to thrive in the long days of back-breaking work at the Salmon Fishery?
- 24. Considering that Roger lived in a shack without electricity or running water on a dirt road with no address, which was a 45-minute walk from the main road, how do you think the Coast Guard found Roger to tell him about his parents' upcoming visit?
- 25. Consider the influence that Mr. and Mrs. Honea had on the development of Roger's faith. Would he have been so receptive to them if his parents had been more engaged and supportive? Did you have an adult who was not your parent who helped you become who you are today?


